January's Luncheon Program – AARP's "Take A Stand" program to keep Social Security Strong for the 21st Century. Sheila Brant – Associate State Director for Advocacy will present. Bring your questions for the Q&A following the presentation.

We worked hard and paid into Social Security so we can get the benefits we've earned when we retire. The world has changed since Social Security was signed into law 81 years ago. It is time to update Social Security for the 21st century so we

can keep the promise for our children. They will be reaching retirement age when (2034) current benefits will drop by nearly 25%. It's predicted that will increase poverty in the 65+ age group by 66% or 2,605,200 seniors.

AARP's Social Security Principles are:

- Achieve long-term solvency and adequacy – ensure benefits for future generations.
- Ensure protection for those most in need – those most reliant on Social Security.
- Ensure fairness – protect current beneficiaries and near retirees.
- Protect core elements – progressive, defined benefits that can't be outlived, inflation protection and benefits related to earnings.

Benefit cuts should not be on the table.

CONSIDER BECOMING A MENTOR

Can you give two hours a week to make a difference in the life of a child? If so, consider becoming a mentor. John Clayton Elementary School in Frankford is in need of more mentors for its highly successful program. There is an especially large need now when many mentors go away for the winter.

Little training is required – just a love of children. Mentors receive a folder for the child or children they mentor with guidance on the day's activities. Primarily you help students improve their reading and writing skills. Even more important is just being someone the child can trust and talk to about their daily life.

NO-COST INCOME TAX RETURNS

Again this year, the AARP Tax-Aide program will offer free tax return assistance and preparation to taxpayers with low and moderate incomes, with special attention to those 50 and older. Taxpayers do not need to be members of AARP to use this service. In the Bethany Beach area, the service will be offered by appointment at the Masterson Center, St. Ann's Church, Route 26, Monday through Wednesday, beginning February 6. Appointments will be from **9 AM** until **1 PM**. The phone number to call to make an appointment, starting January 15, will be **302-858-3575**.

At the time of appointment, taxpayers must present photo ID and proof of SSN for every individual named on the return and must have last year's (2015) Federal and State tax returns. All tax documents, including income statements, proof of deductions and credits, and health insurance statements, should be removed from envelopes. A taxpayer who may be able to itemize deductions should bring a summary of the expenses to be itemized along with supporting documentation.

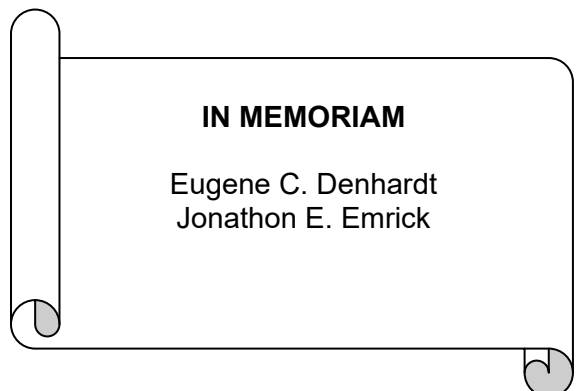

IRS SCAMMERS

Victims receive a call from someone claiming to be from the IRS. The caller says the victim owes money and will be fined or sued if he doesn't pay immediately. The caller demands payment through a wire transfer or a prepaid debit card.

Here's what you should know to protect yourself.

- ★The IRS routinely sends all notices of payment due by mail.
- ★The agency does not initiate phone calls demanding immediate payment by credit card, debit card, or wire transfer.
- ★If you are called and are concerned that you might actually owe money, hang up, and call the IRS directly at 800-829-1040.
